Meeting Agenda and Minutes

USFS Region 2 – New Closure Order

Comments were sent to the USFS Region 2 regarding their proposed NEPA Environmental Assessment for an "adaptive cave management plan". We will review these comments and discuss whether further actions are needed.

Update on written authorization (not permit) cave access to USFS caves in 2013.

Colorado Cave Survey Files

The work to reorganize, catalog, and create a digital archive of the CCS files is complete. There is a small stack of documents that were removed from the files because they probably don't belong. There are also some original survey notes of Wind Cave that should probably be donated to WICA. Finally, there is a rather large stack of duplicate material (mostly maps and newsletters) that should be recycled or donated to grottos. This material should be reviewed by the CCS membership before purging from the files.

Discussion needed on long-term archiving strategies, standards for contributing material, and handling of requests for copyrighted material. Also, looking for someone interested in leading an effort to make the content of the files more comprehensive (e.g. collect missing publications, solicit survey data and maps from cavers, etc.).

Previously members of NCG proposed opening full access to the files to all grotto members. We also began a discussion on possible locations for keeping the physical files to allow better access for cavers. No decisions were made on these items but further discussion can take place.

Motion: Provide a copy of the CCS Files to each CCS representative for use at their respective grotto meetings. This will be used to allow grotto members to view the contents of the files only. Any distribution of the contents of the files must still be approved by a vote of the CCS (as stipulated in the bylaws). If the representative vacates their post they must pass the information on to their replacement or return it to the CCS Chair in a timely manner.

LaSunder Cave Management Plan

The final work trip planned for LaSunder happened in August and human impact photo monitoring was conducted. A final report was sent to the BLM along with recommended changes to the management plan that were discussed during past CCS meetings. A temporary management plan agreement extension was signed to allow time to review these longer-term plan changes.

Colorado Parks and Wildlife Bat Surveys

Biologists with CPW have been conducting external and internal bat surveys as well as using data loggers to collect bat acoustic and microclimate information from various caves and mines around the state. They periodically request help from the caving community to lead these trips. Discuss issues and opportunities to contribute to these survey efforts.
